### STAKEHOLDER ENGAGEMENT/ INVITATION OF COMMENTS AND FEEDBACK ON PROPOSED STANDARD LEVY ORDER 2023 AND REGULATORY IMPACT ASSESSMENT (RIA)

The standards levy order became operational on the 1st of July 1990 vide legal notice 267. The levy order contains provisions as to the evidence by which a person's liability to the levy or his discharge of that liability may be established, and as to the time at which any amount payable by any person by way of the levy shall become due and the way it shall be recoverable by the Director. It also contains provisions in relation to different classes or description of industry.

Pursuant to the Statutory Instruments Act, 2013, The Kenya Bureau of Standards (KEBS) hereby invites stakeholders, manufacturers: electrical; civil; textile; chemical; mechanical; food and agriculture, professional bodies/associations, non-state actors, development partners and the public to submit comments and feedback on the proposed levy order 2023 and the Regulatory Impact Assessment (RIA).
