	Secondly, for the Articles of Incorporation and financial audit reports - the memorandum for the past 5 years are available but it is a huge volume of over 1000 pages and that is a lot of text that needs to be translated to English and notarized. It will take more than 3 weeks due to be translated and notarized due to Chinese New Year Celebration in which most notarization organizations are closed. We are facing a huge challenge on this, can we bring the tender documents to Kenya for translation and notarization? (Page 25)	No. The tender requirement remains as is.
